



# CAMPER'S HOLIDAY CAMPGROUND

## RULES AND REGULATIONS

Welcome to Camper's Holiday. To make your stay more enjoyable, please observe the following rules:

1. Park on the paved portion of the site. Pads must be placed under all jacks.
2. One (1) RV per site and a maximum of two (2) additional vehicles on the paved area if space permits, **NO PARKING ON THE GRASS**. Side-by-sides and ATV's are **PROHIBITED**.
3. Utility trailers, car dollies, etc., must be parked in the designated area at the upper end of the campground along the fence behind the store. First come, first serve. No parking any type of vehicle along other fence area. Proof of current registration and current plates are required. See the gatehouse for a parking permit.
4. **PETS** are welcome but must always be under control and on a leash. Two (2) pets per site. No barking dogs. **ALWAYS** clean up after your pet and properly dispose of all waste, including in the Pet Exercise Area. Proof of current vaccinations, including Rabies, is required. Except for ADA, Title II, and III service dogs, pets are prohibited in buildings, pavilions, or swimming pool areas. Pet pens are **NOT** to be any taller than 32" high and 50 square feet in size. Pet pens must be at **LEAST 5'** from the road and from the other sites around you and **MUST NOT** be permanent. Pets are **NOT** to be left in the fenced area alone. Do **NOT** use other peoples sites as your pets bathroom. Make sure all gates are closed when leaving the dog run.
5. Auto, boat, or golf cart repairs and oil changes are prohibited in the campground.
6. RV patio mats are **ONLY** permitted on the asphalt pad, **NOT** in the grass.
7. The speed limit is 10 mph at all times in all park areas.
8. Quiet time is 9 p.m. to 7 a.m.
9. Check-out time is 11:00 a.m.
10. Registered guests are responsible for the conduct of everyone in their party. If you are expecting guests, please notify the gatehouse attendant. If guests arrive after gatehouse hours, you are responsible for admitting guests.
11. Follow all Hernando County water restriction rules. See Gate House for more information.
12. Laundry facilities are available. Hours are posted in the laundry facility. No drying or washing of animal bedding is permitted. Do not overload machines. If a machine does not operate correctly, please place a sign on it and notify gatehouse personnel.
13. No business shall be conducted in the campground.
14. No nails or screws in trees. Hangers or hooks on pantries only.
15. Campfires are **NOT** allowed on individual sites. No fireworks, firearms, firecrackers, or illegal drugs are permitted.

16. Swimming pool hours are from 9:00 a.m. to 9 p.m. NO lifeguard in attendance. Children under twelve (12) must be accompanied by an adult, at least 18 years of age. Please observe all rules listed in the pool area. Call 911 for emergencies.
17. All buildings, shelters, and pool areas are non-smoking. Refrain from smoking within 25' of any building. Dispose of butts properly.
18. Enjoy Lake Sparkman for fishing or boating. Florida fishing regulations apply. We recommend catch and release only. Boat motors are limited to 3.0 electric. Florida laws prohibit feeding the alligators. Fishing is only permitted from the dock.
19. Owners who store their RV or other equipment during the off-season (summer months) must move all equipment to the designated storage area before leaving the campground. The owner will be responsible for moving all equipment in and out of storage. Camper's Holiday employees are not permitted to move RV's or other equipment. All unattached steps, sewer/water lines, etc., must be removed and properly stored by the owner. Camper's Holiday is not responsible for any damage.
20. Owners of unoccupied RVs on a campsite other than a designated storage site will pay the specified lot rate, not a lesser storage rate fee.
21. All RV units must be road-worthy. Camper's Holiday reserves the right to refuse entry to any RV deemed to be in poor condition. Any RV that is 10 years or older must have prior approval before camping.
22. When the owner of a unit presently in the campground transfers/sells ownership to another individual, the Board of Directors, or representative thereof, will determine, based on RV condition, whether the unit may stay in the campground on its current site. Remember you are selling your RV, not the site it sits on.
23. Camper's Holiday reserves the right to refuse entry to any individual and to evict person (s), without refund, for failure to abide by any of the above rules and regulations and for behavior detrimental to the campground.
24. Park facilities are used at your own risk. Camper's Holiday assumes no responsibility for accidents or injuries to campers and/or guests, loss of property, or damage for any reason, including fire, thefts, or acts of nature.
25. Camper's Holiday reserves the right to seek compensation for vandalism or destruction of Camper's Holiday property.
26. Safety - in the event of a rare tornado, the safest buildings to go to are the restrooms, not the Recreation Hall. If the power is out for any length of time, the Rec Hall has a generator for power. DO NOT TURN ON A/C.
27. NO alterations can be made to any campsite without the Campground Manager's approval. This includes but is not limited to sod, pavers, decking, and tree trimming.
28. All Children under the age of 12 MUST be accompanied by an adult at all times.
29. You are responsible for keeping your campsite neat and tidy at all times.
